- To provide Community-based Intervention Programmes, preventive services and information for youth and adults with life-controlling problems regardless of race, religion and age, and to provide facilities to run such programmes and services.
- c. To help our residents and all participants under the Intervention Programmes in pre-employment training opportunities, secure employment, complete their education and become useful and productive citizens.
- d. To assist in reconciliation and restoration of family relationships by providing opportunities for family sessions, counselling, seminars and other services and/or referrals.
- e. To network with such agencies and relevant authorities in the Aftercare of recovering substance abusers, drug addicts, alcoholics, juvenile delinquents, teenage gangsters, ex-prisoners, and others with related social difficulties.

# **Staffing**

As at 31 December 2017, there were 20 permanent full-time staff.

# **Activities**

Drug & Alcohol Recovery (DARE) Centre received a total of 32 admissions to the residential programme in 2017. Out of which 24 were from the Halfway House Service Model (HSM), 7 were from Walk-In, and 1 from Residential Aftercare Support Programme (RASP). 35 individuals successfully completed their programme.

# **Pastoral Care and Outreach Department (POD)**

POD provides In-Care to those incarcerated through a group 40 volunteers. These volunteers conduct weekly program within Changi Prison Complex, 8 new volunteers were added to the team and together they registered a total of 3840 volunteered hours in 2017.

POD conducted Enrichment, Motivation, Befriending, Aftercare and Religious programmes to those in need. 15 of TC volunteers were recognized by Prison Service for their long services, which ranged from 3 to 25 years.

## **Teen Challenge Enterprise Ltd (TCE)**

TC Mover and Woodwork, the twin social enterprises of TCE provided employment to 16 individuals in 2017. All 16 of them were former residents of DARE programme. 8 of them are full time staff while the rest were recruited throughout the duration of their employment phase in their recovery programme, typically between 3 to 6 months.

The financial year of TCE ended with a small profit. The Social Impact or the Social Return of Investment (SROI) of TCE is immeasurable through the visible change in lifestyle of former residents, sustainable employability and their reintegration to society.

## **Fund Raising Event and Activity**

The primary fund raising activity of TC is the 17th Charity Golf event. There were 108 participants and around \$234K was raised from this annual fund raising event.

Contributions to TC derived primarily from government grant, organizations, companies, churches and individuals.

Teen Challenge Singapore does not own any property.
